1.	<u>Replacement of Electrical Panel board:</u> The Cleaning and painting of Electric motor with one coat of Epoxy primer and two coats of Grey enamel paint, replacing of existing damaged panel board with new board using 18 mm thick plywood of size 7' X 2.5', 3 numbers of Porcelain fuse unit, 3 numbers of Indicator lamps and 1 number of Switch board of size 12" X 5" with internal wirings, providing of 2 numbers of new CFL light fittings in the winch house. The cost includes Materials, labour cost, tools & tackles and consumables etc)	1 Job		
2.	<u>Repair & Reconditioning of Steel Wire ropes:</u> Dismantling of existing steel wire ropes from the Uphaul and Downhaul winches, removal of damaged portions of wire ropes, splicing and joining of wire ropes, cleaning and applying with heated cadmium compound (supplied by the department) on the wire ropes. The cost includes Materials, labour cost, tools & tackles etc)	1 Job		

TERMS AND CONDITIONS

1. The validity of the quote shall be 90 days.
2. The Winch and cradle assemblies and Slipway at the New Port may be inspected at any time during office hours for assessment of value.
3. The rate is to be quoted in the format as given in the Enquiry form above.
4. Quotation submitted should not specify any conditional/unconditional rebates.
5. The work shall be carried out as per the direction of Department Engineers.
6. The contractor/firm has to submit The Earnest Money @ 2% of the quoted amount in the form of Demand Draft of nationalized bank / scheduled bank to the credit of the Executive Engineer , Port Department, Puducherry, and Performance guaranty for an Amount equal to 5 % of the quoted amount, in the form of fixed deposit Receipt or Demand raft drawn in favour of Executive Engineer, Port Department, Puducherry, from a nationalized Bank, if the work is awarded to him.
7. Deduction like the Income Tax and Security deposit @ 5 % (Amount inclusive of EMD) of the total value of work will be deducted in each running bill.
8. No advance payment will be made.
9. Part payment will be made against the work completed, upon presentation of bills.
10. Taxes and duties, if any, are to be included in the quote itself.
11. Completion period of shall be 30 days from the date of issue of work Order and shall be strictly adhered to. Default in the stipulated completion schedule without satisfactory cause will result in cancellation of order, if placed on you.
12. The undersigned reserves the right to accept or to reject any Quotation without assigning any reason thereof.
13. For any dispute or legal matter arising out in respect of this contract, the jurisdiction of the court shall be Puducherry only.
